#### **REQUEST**

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPROVING THE TOWN'S LOCAL AGENCY CERTIFICATION QUALIFICATION AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION ("FDOT") IN ORDER TO ALLOW THE TOWN TO RECEIVE FEDERAL STIMULUS MONIES FOR TRANSPORTATION PROJECTS AND AUTHORIZING THE TOWN MANAGER TO EXECUTE THE AGREEMENT AND ALL FUTURE FORMS AND AGREEMENTS REQUIRED FOR THE TOWN'S PARTICIPATION IN THE PROGRAM ON BEHALF OF THE TOWN

#### **BACKGROUND AND ANALYSIS**

The federal stimulus legislation has provided the state of Florida funds to disperse to encourage a financial and employment recovery. The state Department of Transportation has made an allocation to the Miami Dade MPO to further distribute to local governments. Under the leadership of Chairman Dennis Moss, the MPO determined that funds be distributed on the basis of population which means that Cutler Bay will receive some \$941,285 for surface transportation issues as approved by FDOT and the MPO. The list of eligible projects in the approximate value of the allocated amount was to be submitted to FDOT no later than noon February 22. The Town staff has submitted a list of transportation projects within the Town to FDOT. The staff has made every effort to address previously identified transportation needs and to distribute the projects through out the Town of Cutler Bay.

In order to receive federal stimulus funding, the Town is required to obtain certification from FDOT as a certified local agency under FDOT's Local Agency Program ("LAP"). **WHEREAS**, in order to receive federal stimulus funding, the Town is required to obtain certification from FDOT as a certified local agency under FDOT's Local Agency Program ("LAP"); and

**WHEREAS**, the LAP requirements include the requirement that the local agency enter into a Local Agency Certification Qualification Agreement, a copy of which is attached hereto as an exhibit to this resolution; and

**WHEREAS**, the Town desires to enter into the Local Agency Certification Qualification Agreement with FDOT and to authorize the Town Manager or his designee to execute all further documents and agreements necessary in order for the Town to receive federal stimulus funds and participate in the LAP.

Additionally, the Town Manager is hereby authorized to sign any and all additional agreements or documents and provide any further documentation to state or federal authorities required in order for the Town to receive federal stimulus funding or other funding from the state of Florida for Town infrastructure projects.

Re: LAP Program and Certification Process

The Florida Department of Transportation (Department) is empowered by legislative authority to contract with other Local Agencies to plan; develop, design, acquire right-of-way, and construct transportation facilities. The Department reimburses these Local Agencies for services provided to the public. The formal name given to this project is the Local Agency Program (LAP). Authority for LAP is provided in Sections 20.23(3) (a), 334.044(7), 339.05, and 339.12 of the Florida Statutes.

The program was established in 1991 with the enactment of the **Intermodal Surface Transportation Efficiency Act (ISTEA)**. The Department has assigned the responsibility of administration and program oversight to the State LAP Administrator in the Central Office. In each District, a District LAP Administrator manages the program. The District LAP Administrator is supported by and provides project level direction and oversight through the Offices of Planning, Environmental Management, Design, Right of Way, and Construction.

The LAP Process consists of eight steps: Project Selection; Local Agency Certification; Federal Authorization; LAP Agreement; Plans, Specifications, and Estimates; Local Agency Advertisement and Award; Project Management a Development; and Project Close-out (Final Inspection and Acceptance). Although not listed, the above steps contain a number of sub-steps. The majority of funds used for LAP projects are spent during the construction phase; however, a project may receive Federal Funds for one or more of its phases. These phases are:

- Planning
- Preliminary Engineering for Project Development and Environmental (PD&E)
- Design
- Right of Way Acquisition
- Construction
- Construction Engineering and Inspection (CEI)

Each Local Agency wishing to participate in LAP must complete the Local Agency Certification Qualification Agreement (Form No. 525-010-33) and must be interviewed by the applicable District LAP Administrator. A Local Agency is defined as a unit of government with less than statewide jurisdiction or any officially designated public agency or authority of such a unit of government that

has the responsibility for planning, construction, operation or maintenance of, or jurisdiction over, a transportation facility. The term includes, but is not limited to, a county, an incorporated municipality, a metropolitan planning organization (MPO), an expressway or transportation authority, a road and bridge district, a special road and bridge district or a regional governmental unit. If qualified, the Local Agency will receive one of the following certification types:

- Full administration of all project types (except for Environmental Class of Action Determination and Right of Way Certification)
- Project Specific (limited to a project-type)
- Risk-Based (determined on a project-by-project basis)

#### LAP Agreement

A LAP Agreement is developed and executed for each LAP project. The purpose of the LAP Agreement is to ensure that the correct amount of Federal fund is spent according to all relevant State and Federal laws and regulations.

Submit the following to the District LAP Administrator:

- Two copies of the Local Agency Certification Qualification Agreement (Form 525-010-33)
- Local Agency's Organizational Chart
- Narrative addressing its capabilities, staff, and experience in specific areas where certification
  is requested, focusing on previous "Federal Experience" (i.e. Community Development
  Block Grants, managing Federal Grants, etc.)
- Transmittal letter signed by an appointed elected official of the Local Agency
- Copy of its latest Single Audit Report
- Completed Administrative Checklist
