

List Of Sponsored Ordinances and Resolutions

Beginning with the May, 2007 meeting, at the suggestion of Ed MacDougall, the name of the council member who proposed an ordinance or resolution was added to the agenda.

On the following pages are the names of council members and the items they sponsored. Not all items listed were passed by the town council. Ordinances and Resolutions, sponsored by town staff are not listed.
